## **AFFIDAVIT IN SUPPORT OF ARREST WARRANT**

IN THE MATTER OF:

The People of The State of Colorado

V.

Christopher Peter Lambros, DOB 06/11/1961

and in support of the Application for Arrest Warrant, Detective Charles Rojo, hereinafter referred to as "Affiant", presents the following Affidavit in support of Arrest Warrant and asserts the following:

1. That the Affiant is of lawful age and is a duly sworn law enforcement officer currently employed by the Grand Junction Police Department and was so at all times relevant to the facts contained herein. All of the information herein contained was compiled by the Affiant in the course of a criminal investigation, including speaking with fellow law enforcement officers and named citizens. All locations referred to are in the County of Mesa, State of Colorado, unless specifically noted otherwise.
2. On 7/9/2022 at around 2048, Officer Alcon was dispatched to take a report of potential misconduct that occurred at St. Mary's Hospital at 2635 North 7th Street in Grand Junction, Mesa County, Colorado. The reporting party, \_\_\_\_\_, who is a \_\_\_\_\_ at the hospital, stated a nurse, later identified through law enforcement records as Christopher Lambros (6/11/1961), had been seen by another employee taking photos of a patient's genitals. This was reported to have occurred around 1730 on 7/9/2022. The patient and possible victim's identifying information was also provided by \_\_\_\_\_. The patient in question was \_\_\_\_\_.
3. \_\_\_\_\_ provided contact information for the involved parties, including Lambros and the witness, later identified verbally as \_\_\_\_\_. Officer Alcon called \_\_\_\_\_ who stated she had gone to intensive care unit room \_\_\_\_\_ to check on the patient there. When she came into the room, the lights were off and the curtain was drawn. When she pulled back the curtain she saw the patient, who was unconscious, with her gown pulled up, exposing her breasts, and the bed sheet was pulled down, exposing the patient's genitals. \_\_\_\_\_ said she saw a nurse, who she knew as Chris Lambros, with his head on the patient's stomach, with his face toward the patient's feet, with what she believed his right arm



extended, holding what she was sure was an unknown make/model cell phone in a black case, in a position as if he was taking a "selfie" picture. When entered, she said Lambros dropped the phone on the bed and re-covered the patient with the gown and blanket, and then did something with the medical equipment in the room. left and notified her supervisor. said she had not had any workplace or personal issues with Lambros other than him occasionally being "cranky."

4. Officer Alcon later went to Lambros' house at in Grand Junction. Officer Alcon contacted Lambros and asked him about what happened. He said he was giving the patient an injection for blood clots, which is administered in the stomach area, which was why the patient was uncovered. He denied having taken any pictures and could not say why would say that he was taking a picture. He did say that he and had some petty workplace issues but did not think that would cause her to make the accusation. Lambros did give consent for Officer Alcon to look through his photos and applications after being told it was voluntary and he could refuse. Officer Alcon looked through his pictures and applications and did not locate any photos consistent with what would have been taken during the incident. However, based on training, experience, and discussion with other officers, Officer Alcon knew that photographs on phones can be deleted, hidden, or stored in other applications other than the phone's photo applications. Officer Alcon seized Lambros' phone because he found there was probable cause to seize his phone, which was an unknown make/model Android smartphone, with a folding screen, in a black "Fold" case, to apply for a search warrant for evidence of the crime of Invasion of Privacy for Sexual Gratification in violation of CRS 18-3-405.6. The actions described by would constitute taking photographs of the victim's intimate parts where the victim would have a reasonable expectation of privacy. Based on Officer Alcon's training, experience, and discussion with other officers, there would be no reason for Lambros to take pictures other than for the purpose of sexual gratification.
5. Lambros refused to provide an unlock PIN for his phone. Additionally, Officer Alcon was unable to put the phone into airplane mode after seizing it, as it required a PIN. Officer Alcon took the phone to the police department and booked it into evidence.
6. Officer Alcon wrote a search warrant for the phone. This search warrant was signed by Judge Robison on 7/13/22 and assigned search warrant number 22SW497. The search warrant granted access to the phone information between the dates of 6/9/22 through 7/9/22.
7. A digital forensic analysis of the phone was done by DFA Huslig. DFA Huslig found photographs and videos of Lambros posing with a number of victims who were unconscious, in the hospital setting. Lambros was photographing himself sucking on victims' breasts and digitally penetrating victims. Trash/deleted files were found

within the date range of the original search warrant (6/9/2022 - 07/09/2022). A database related to the deleted files was searched, which indicated that additional multimedia files will be present on this device outside of the original search warrant dates. The database tracks deletion of files starting at 4/30/2022 - 7/09/2022. This database shows that 168 photos/video were deleted between this span. Android phones can contain multiple user directories.

8. On 10/13/22 I wrote a search warrant to broaden the scope of the phone search warrant. This search warrant was signed by Judge Henderson on 10/13/22 and assigned search warrant number 22SW687.
9. DFA Huslig found accounts on Lambros phone which may be associated to cloud storage. Android phones are known to be associated with email accounts to download and upload information. The accounts found on the phone were \_\_\_\_\_, and \_\_\_\_\_. I preserved these accounts through Google on 10/13/22 and received confirmation: 25340668. I also wrote a search warrant to Google for the above accounts; this search warrant was signed on 10/13/22 by Judge Grattan and assigned search warrant number 22SW688. As of this writing, Google has not produced the evidence from this search warrant.
10. Upon further investigation, Lambros is seen on 4/30/22, in two videos, sucking on the breast of an unknown female; Lambros does not say her name. On 6/24/22 there were five videos of Lambros sucking on the breast of a female he calls \_\_\_\_\_. Video recovered from 6/24/2022 at 17:30 hours, Lambros can be heard whispering to the camera saying "don't ever get rid of these videos" and "you need to keep them forever... this is your Dexter collection". On 6/25/22 one video was recovered of the male sucking on the breast of an unknown female, no name is mentioned. On 7/9/22 one video was recovered of Lambros calling the female \_\_\_\_\_ prior to sucking on their breast. Additional videos were recovered on 7/9/2022, however no name was mentioned by the male. All videos appear to be in a hospital setting with Lambros wearing scrubs.
11. As of this writing, I am working with St. Mary's Hospital in an effort to identify victims. It appears there are a minimum of three victims, to include \_\_\_\_\_

That the Defendant is identified based upon **Grand Junction Police Department** records as follows: **Christopher Peter Lambros**, DOB **06/19/61**, **White/Male**, **5'10"** tall, **190** pounds **Brown** hair **Brown** eyes.

That the Victim is identified as \_\_\_\_\_ and at least two other victims referred to as **Jane Doe**.



That based upon the above information, the Affiant has probable cause to believe the following:

1. Sexual Assault (a class three felony), in violation of CRS 18-3-402 (3 counts)

That your Affiant respectfully requests the issuance of a warrant for the arrest of Christopher Peter Lambros, for the above-named offenses.
