On or about 03/28/2024 02:59 PM, within the City of Englewood, County of Arapahoe, State of Colorado, and as grounds therefore states as follows: That this Affiant is a Peace Officer with the Englewood Police Department and that the following information was obtained by me personally, and from the official records of this agency, as well as from documents received from other law enforcement personnel.

On March 28th, 2024, Your Affiant, Englewood Police Detective BRIAN MARTINEZ, hereinafter referred to as I or me, was assigned Englewood Police case report #EPD24-02401 for follow-up. Unless noted otherwise, all incidents related herein occurred within the City of Englewood, County of Arapahoe, and State of Colorado. Through a review of official reports and my follow-up investigation, I learned the following:

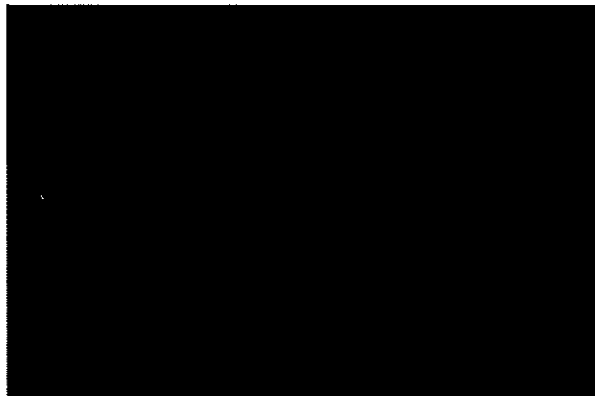

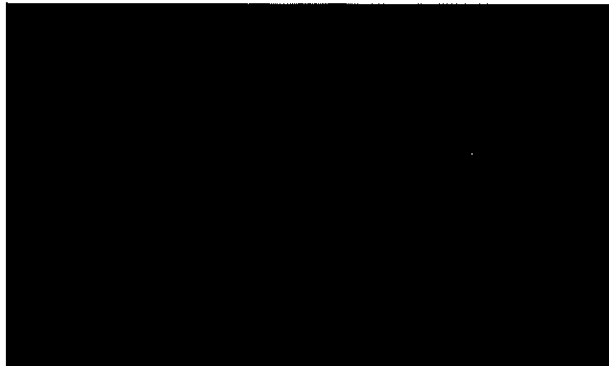

On 03/28/2024, I was assigned to an assault on an at-risk juvenile case that occurred at the [REDACTED] located at [REDACTED] State of Colorado, State of Colorado. This case was initially started by Littleton Police Department and when it was learned the incident occurred in Englewood the case was turned over to Englewood Police.

I met with Littleton Police Detective Hronick who was the initial detective assigned to this case and I learned the following:

- On 03/19/2024, [REDACTED] called Littleton Public School Transportation regarding injuries to [REDACTED]
- [REDACTED] is a student at [REDACTED]
- [REDACTED] came home with bruises on 03/18/2024, to [REDACTED] foot that was not there the previous day.
- [REDACTED] called and spoke with LPS Transportation Director Marcy K. Phelps and asked Marcy to review surveillance footage.
- Marcy reviewed surveillance footage from the bus that [REDACTED] takes home from the school.
- Marcy reviewed the surveillance footage from the bus and noticed Kiarra Jones who is a Paraprofessional for Littleton Public Schools had assaulted [REDACTED]
- Marcy called Littleton Police regarding what she had observed.
- Hronick stated he watched surveillance footage of Kiarra assaulting [REDACTED] on the bus on 03/18/2024.
- Hronick stated during the investigation, he learned the incident started in the City of Englewood.

I was given a thumb drive of surveillance footage of the assaults. On the thumb drive, there was recorded footage of Kiarra assaulting [REDACTED] on 02/13/2024, 03/01/2024/ and 03/18/2024.

I first watched the surveillance footage on 02/13/2024 and learned the following:

Bus surveillance and audio footage on 02/13/2024:

Kiarra is hired as Paraprofessional. Kiarra is seen wearing a blue jump suit with a multicolor strip down the side. [REDACTED] is wearing a light-colored t-shirt.

- Start date and time is 02/13/2024 at 14:48 according to surveillance video.
- Kiarra is seen on the bus sitting in the last seat on the driver's side of the bus.
- [REDACTED] is seen sitting on the left side in the second seat on the door side of the bus.
- [REDACTED] is seen being belted in by an adult male party.
- Kiarra is seen giving the male a bungee cord to give to [REDACTED]
- At 14:50:24, Kiarra reaches out to shake [REDACTED] hand and [REDACTED] reaches out. Kiarra softly taps [REDACTED] hand.
- At 14:51:54, Kiarra sits in the same seat as [REDACTED] and forcefully pushes [REDACTED] head down towards the floor. She lets [REDACTED] back up and [REDACTED] is seen pushing her arm away. Kiarra then rubs [REDACTED] head.
- 14:52:13 Kiarra rubs [REDACTED] head and [REDACTED] tenses up as she is touching [REDACTED]
- 14:52:28 Kiarra raises her right arm up to [REDACTED] and softly touches [REDACTED] with her elbow.

- 14:52:31 Kiarra puts her index finger underneath [REDACTED] chin and pushes up forcing [REDACTED] head back.
- 14:54:25 Kiarra then reaches over to [REDACTED] legs and appears to be unwelcomed touching due to [REDACTED] reaction tensing up.
- 14:54:55, Kiarra looks towards the bus driver and then hits [REDACTED] in the mouth with the back of her right hand.
- [REDACTED] is seen holding [REDACTED] arms to [REDACTED] chest before Kiarra pushes [REDACTED] arms down [REDACTED] appears to be scared.
- Kiarra then takes the red bungee cord away from [REDACTED] and gives it to another passenger on the bus.
- 14:57:35, Kiarra is doing something [REDACTED] does not like due to [REDACTED] reaction and pushing her hand away. Kiarra continues unwelcome touching due to [REDACTED] reaction. It also appears [REDACTED] is trying to unbuckle [REDACTED] Kiarra continues this behavior as she is looking towards the bus driver.
- [REDACTED] is seen breathing heavy.
- 14:58:45, Kiarra looks towards the bus driver, and she hits [REDACTED] in the mouth with the closed fist of her right hand. The punch is so hard [REDACTED] head goes back and hits the seat.
- [REDACTED] is seen possibly trying to unbuckle the seat belt. It appears [REDACTED] is checking [REDACTED] mouth by the way [REDACTED] is moving it.
- [REDACTED] is still breathing heavily.
- 14:59:25, Kiarra appears to touch [REDACTED] in an unwelcome manner due to [REDACTED] reaction [REDACTED] is bringing [REDACTED] arms to

chest and moving legs around.

- 14:59:42, Kiarra hits in the abdomen.
- 15:00:53, Kiarra elbows twice in the chest as she is speaking with the bus driver.
- 15:01:14, Kiarra elbows in the face.
- flinches and appears to be scared when Kiarra rubs the back of head.
- 15:01:51, Kiarra appears to be touching in a manner unwelcomed because of reaction.
- 15:01:59, Kiarra puts her right hand behind head and pulls hair.
- Kiarra puts her hand out towards and which time slaps her hand (giving 5).
- Kiarra puts her right-hand underneath chin and turns away from her. She continues to rub head and continues to turn away from her. It is apparent that does not want Kiarra touching.
- 15:03:30, Kiarra starts touching because you can see pushing her hand away.
- 15:03:51, Kiarra is seen possibly grabbing onto left arm and putting it behind own back. She continues to touch left arm in an unwelcome manner. is struggling to gain control of arm. Kiarra then elbows in the abdomen. Kiarra then grabs by the jaw, reaches behind head, and forcefully pushes head down. Once head is down, she punches in the back with a closed fist.

- 15:05:35, Kiarra starts touching [REDACTED] in an unwelcome manner as [REDACTED] starts moving around.
- Kiarra then appears to tickle [REDACTED]
- 15:06:10, Kiarra then puts her arm around [REDACTED], and [REDACTED] senses up. She then forcefully pushes [REDACTED] head down towards the floor.
- 15:06:33, Kiarra puts her arm around [REDACTED] again as [REDACTED] senses up again. Kiarra forcefully pushes [REDACTED] head down towards the floor. When she lets [REDACTED] up, [REDACTED] appears to be crying. Kiarra starts rubbing [REDACTED] head.
- 15:06:58, Kiarra puts her arm up above [REDACTED] and forcefully pushes her elbow on the head of [REDACTED] making [REDACTED] lean forward. She put her arm around [REDACTED] and started to push [REDACTED] towards the floor. She then removes her arm away from [REDACTED]
- 15:07:27, Kiarra then touches [REDACTED] in an unwelcome manner due to [REDACTED] reaction. She then grabs [REDACTED] from behind the back of the neck and forces [REDACTED] towards the floor. When Kiarra allows [REDACTED] up, [REDACTED] is crying.
- Kiarra gets up and [REDACTED] is breathing heavily and watches Kiarra. Kiarra is placing a backpack on the seat where she was seating and [REDACTED] is seen flinching.
- 15:11:54, Kiarra starts touching [REDACTED] in an unwelcomed manner due to [REDACTED] reaction. [REDACTED] is seen bending over and possibly retrieving something on the floor. [REDACTED] is seen bending over, and she holds [REDACTED] down.
- Kiarra reaches to the back of [REDACTED] head and starts rubbing it. [REDACTED] starts to flinch when Kiarra is touching [REDACTED]. It is obvious [REDACTED] does not want Kiarra touching [REDACTED] due to [REDACTED] pulling away and putting [REDACTED] back towards her.

- [REDACTED] has something because Kiarra keeps taking something away from [REDACTED] and she appears to be throwing it onto the floor. [REDACTED] is seen bending over.
- 15:13:52, Kiarra tosses something on the floor and [REDACTED] bends over to retrieve it. As [REDACTED] is bent over, Kiarra is forcefully holding [REDACTED] down. [REDACTED] does try to push back up and is pushing Kiarra away. Kiarra uses both hands to hold [REDACTED] down as [REDACTED] struggles to get back up. When she allows [REDACTED] backup [REDACTED] is crying. Kiarra holds [REDACTED] down for approximately 17 seconds.
- Kiarra tries to console [REDACTED] and tells [REDACTED] is ok.
- Kiarra starts to rub [REDACTED] head and [REDACTED] is tensing up and flinching.
- It appears Kiarra takes something from [REDACTED] and throws it onto the floor.
- 15:15:02, Kiarra throws something on the floor and [REDACTED] bends over to retrieve it. Kiarra again holds [REDACTED] down towards the floor. Kiarra is using both hands to hold [REDACTED] down and [REDACTED] is seen trying to get back up.
- 15:14:38, Kiarra puts her arm above [REDACTED] head as [REDACTED] tenses up and flinches. She brings her arm down and pushes [REDACTED] head forward and then puts her arms around [REDACTED]. Kiarra then grabs [REDACTED] head with both hands and forces [REDACTED] down towards the floor. She then pulls [REDACTED] hair as [REDACTED] is trying to get up. She allows [REDACTED] backup, and [REDACTED] is crying.
- 15:16:18, Kiarra grabs [REDACTED] and forcefully pulls [REDACTED] forward. She then elbows [REDACTED] in the abdomen.
- 15:16:37, Kiarra then elbows [REDACTED] very forcefully and then punches [REDACTED] in the legs.
- 15:17:36, While watching the surveillance footage, I observed Kiarra then reached across the aisle and pull the hair on the back of the head of another student, later identified as [REDACTED]. [REDACTED] turns around and Kiarra puts her left hand out to [REDACTED] and Kiarra shook hands. It appears Kiarra is trying to hold onto [REDACTED] hand,

but [REDACTED] pulls away.

• 15:19:04, Kiarra appears to elbow [REDACTED] again in the abdomen. I can't see what exactly happens because the back of the front seat is blocking the angle, but Kiarra possibly assaults [REDACTED] because [REDACTED] head hits the back of the seat forcefully. Then [REDACTED] head shakes as if [REDACTED] is getting hit. She then puts part of her body on [REDACTED] and she pushes [REDACTED] down.

• 15:19:38, Kiarra puts her arm around [REDACTED] and it appears [REDACTED] is trying to stop her by forcing [REDACTED] head against the backrest. She forces her arm around [REDACTED] and pulls [REDACTED] closer to her. She appears to be harming [REDACTED] due to reaction and [REDACTED] turning towards her and trying to push away. She then forces [REDACTED] head down towards the floor as [REDACTED] tries to resist. [REDACTED] heard crying. I am unable to see what Kiarra is doing to [REDACTED] after [REDACTED] comes up because her body is blocking the camera view. She continues to touch [REDACTED] because [REDACTED] is seen tensing up.

• 15:20:32, Kiarra then hits [REDACTED] in the abdomen. She then leans onto the seat in front of her blocking camera view.

• 15:22:19, Kiarra puts her right arm behind [REDACTED] and [REDACTED] flinches and tenses up. Kiarra then puts her arm around [REDACTED] and [REDACTED] tenses up again. She then starts to rub [REDACTED] head and face. She again puts her right arm behind [REDACTED] and forces her arm behind [REDACTED] head as [REDACTED] tenses up again. She then forcefully pushes [REDACTED] head down. She then punches [REDACTED] twice underneath the chin. The hits were so hard it forced [REDACTED] head back each time.

• [REDACTED] is seen watching Kiarra after getting hit and tenses up when she would move her arm.

• 15:23:54, Kiarra punches [REDACTED] underneath the chin again which I could hear. The punch was so hard it forced [REDACTED] head back. She then hit [REDACTED] in the abdomen and then hit [REDACTED] in the face with her right hand. [REDACTED] head goes back when hit in the face. She reaches across [REDACTED] body to get the seat belt and [REDACTED] tenses up. It is evident [REDACTED] is afraid of Kiarra due to [REDACTED] tensing up and looking over at Kiarra when she moves.

• 15:26:22, Kiarra starts touching [REDACTED] again and [REDACTED] starts to tense up again. It appears she is hurting [REDACTED] again because [REDACTED] is squirming in [REDACTED] seat. Then it appears she is kicking [REDACTED] because the way the right side of her body is moving, and they both keep looking to the floor. Kiarra bends over to look at the floor and appears to start kicking [REDACTED] again. [REDACTED] expression shows something is happening. Unable to see due to the view of the camera.

• 15:28:34, Kiarra touches [REDACTED] on the chest with her right hand. Unknown what she is doing but [REDACTED] appears to be

uncomfortable by tensing up. It also appears Kiarra is still kicking or stepping on [REDACTED] due to both of their reactions. They both kept looking at the floor and the slight movements of their lower bodies. She reaches over with her right hand and does something to [REDACTED] because [REDACTED] hunches over. During the possible kicking, I observed underneath the front seat a loose shoe appears. It may have been [REDACTED] shoe that Kiarra kicked off.

• 15:29:38, Kiarra reaches towards [REDACTED] face and hits [REDACTED] on the chin then puts her right-hand underneath [REDACTED] chin on the neck and it appears she slightly squeezes, as she is removing her hand. [REDACTED] reacts to the hand on neck by raising [REDACTED] arms up to [REDACTED] side.

• 15:30:28, Kiarra puts her right arm behind [REDACTED] head again as [REDACTED] tenses up when she does this. She forces her arm behind [REDACTED] head and [REDACTED] tenses up as she does this. Kiarra then puts her right hand on the back of [REDACTED] neck and the left hand on [REDACTED] head and forces [REDACTED] down towards the floor. Unable to see what she is doing to [REDACTED] but she is adjusting her arms.

Kiarra is 28-year-old women and according to her DOR she is 5'08" and 235 lbs.

At no time as I was watching this surveillance video did I see [REDACTED] perform any actions to warrant the assault Kiarra performed on [REDACTED]

[REDACTED] is diagnosed with [REDACTED] among other developmental disabilities, which is an Intellectual and Developmental Disability as defined in CRS 25.5-10-202(26)(a) & (b). [REDACTED] was diagnosed with this Intellectual and Developmental Disability prior to [REDACTED] meets the definition of an At-Risk Juvenile per CRS 18-6.5-102 Definitions.

Kiarra Monte Laron Jones dob 03-05-1995, is employed by the Littleton Public Schools District as a Paraprofessional who works with the Individual Education Plan Team, and she is authorized to act as a caretaker of individuals who have an Individual Education Plan. During the herein-described incidents, Jones was responsible for the care and wellbeing of [REDACTED] among other developmentally disabled students, while these students were in her care on the bus. As defined in CRS 25.5-10-202(1.6) (b) & (c) and CRS 18-6.5-102 Definitions, Kiarra Monte Laron Jones meets the definition of a caretaker of a person with an Intellectual and Developmental Disability.

Kiarra was positively identified by her Colorado DOR.




