



I was given a thumb drive of surveillance footage of the assaults. On the thumb drive, there was recorded footage of Kiarra assaulting on 02/13/2024, 03/01/2024/ and 03/18/2024.

I first watched the surveillance footage on 02/13/2024 and learned the following:

As defined in CRS 25.5-10-202(1.6) (b) &(c) and CRS 18-6.5-102 Definitions, Kiarra Monte Laron Jones meets the definition of a caretaker of a person with an Intellectual and Developmental Disability.
